DECLARATION OF FINANCES

If it is determined that you are admissible to Oregon State University, OSU can provide you with an I-20 (F-1) or DS-2019 (J-1) only after you submit satisfactory evidence that you have adequate funds for your proposed program of study. Acceptable financial documents must not have been issued (by the financial institution) more than nine (9) months before the term you intend to enroll at OSU and must accompany this form. Be sure to keep copies of these documents as you will need to present them to the U.S. Consular Officer at your visa interview and to the U.S. Immigration Officers at the Port of Entry. Please note: U.S. visa regulations restrict student employment, and therefore, it is important not to rely on employment for income to offset your educational expenses. If you are interested in a graduate assistantship, please contact the department directly for more information. Availability can vary from year to year and many graduate students are offered assistantships only during their second year of study at OSU.

Estimated costs: These figures cover the cost of tuition, fees, and a modest estimate for room, board, books, supplies, health insurance (required of all international students and accompanying family members), and incidental expenses. Summer tuition and fees are not included in the estimates. Costs tend to increase slightly from year to year. To help you prepare financially, Master's degree programs are 2-3 years in length, and Doctoral programs are 3-6 years in length. You and your sponsor must prepare to meet the ongoing costs of your educational and living expenses, not only for the first 12 months, but for the duration of your studies at OSU. Additional resource fees, ranging from \$105-\$1,290 per year, may be required of some majors.
